PLEASE READ THE FOLLOWING INFORMATION CAREFULLY AND PLAN ACCORDINGLY.

I UNDERSTAND:

- ✓ Food Booth application fee is non-refundable.
- ✓ I will sell only three food items from my booth.
- ✓ I cannot sell any type of beverage at my booth.
- ✓ I will provide a certificate of insurance with the Weslaco Chamber of Commerce and the City of Weslaco named as co-insured. (If available)
- ✓ I will provide a photocopy of my driver's license.
- ✓ My vehicle access to the food booth location will be terminated at 8:30 am on Saturday, March 26, 2011. I understand if I arrive after 8:30 am, I will be required to hand carry my equipment to my booth location.
- ✓ I understand vehicles without a parking permit are prohibited behind my booth(s) after 8:30 am. Vehicles parked behind booth may be towed away at owner's expense.
- ✓ Booth sizes are 10'x10', vendors requiring additional space must purchase another booth.
- ✓ Booth locations are assigned on a first come basis. A preferred booth selection does not guarantee the participant that booth. If a participant's first and second choice booth locations are unavailable, the committee will place the participant as close to their choice(s) booth locations as possible.
- ✓ The Texas Onion Fest Committee reserves the right to prohibit at the time of entry or at the time of the festival any material or presentation found offensive or illegal.
- ✓ The Texas Onion Fest Committee will not furnish electrical extension cords or multiple electrical outlet strips (surge suppressors, etc.). Only 10 to 12 gauge extension cords will be accepted.
- ✓ Vendors shall have at least a 5 lb. ABC fire extinguisher with current tag, or show proof of purchase, in booth close to the exit away from stove. Minimize the use of too many extension cords within booth. Fire Marshall will be on site Saturday morning to inspect each booth for compliance with city ordinance.
- ✓ I may not resell or sublet my booth to another vendor.
- ✓ Food booth location will not be reserved unless payment has been received.

- ✓ Temporary food establishment permits will be distributed between 7 AM & 9 AM on Saturday, March 26, 2011. Health Inspector will be on site Saturday morning to inspect each booth for compliance with city ordinance. Booths may not open before being inspected (See attached Health Department Checklist)
- ✓ All food booths must remain open, during Onion Fest hours, 10 AM to 9 PM.
- ✓ Booth vendors agree to hold Onion Fest and its agents harmless from any and all liability whatsoever.

ANY PERSON OR PERSONS ABUSING THE ABOVE POLICIES WILL BE ASKED TO LEAVE THE FESTIVAL GROUNDS IMMEDIATELY AND MAY NOT BE ALLOWED TO PARTICIPATE THE FOLLOWING YEAR AS A FOOD VENDOR.
